PLEASE NOTE:

- All rental gear must be returned in the same condition as it was issued. If you get it muddy, you will be expected to clean it up.
- There will be no more free BBs. You may purchase a kg bag or a "dimebag bottle" of 0.25g BBs for the current price.
- ONLY field batteries and field BBs are allowed in the rental replicas.
- If there is a problem, do NOT attempt to fix the replica yourself. Instead, immediately notify field staff.
- Only the person named on this agreement may turn in their rental kit. Do not have someone else do it. Do not just pile rental equipment on the counter. Each item will be checked back in by staff. If you are leaving partway through the game, it is your responsibility to find a staff member to check you out.
- The replacement cost is indicated above. Repair cost is \$25 per hour plus parts with a minimum labor cost of \$25.
- If you accrue additional charges, you will be presented a bill the next time you check in. **You will not be allowed to rent from the field until it is paid.**

AGREEMENT

I agree to return all the equipment issued to me to the same location I picked it up at, in the same condition as when I received it on the same date issued. I agree to pay any additional balance due to cover the full replacement cost for lost/stolen or damaged items while in possession. Failure to return any equipment issued to me by the specified time will be **regarded as theft and a theft report will be filed with the authorities**. I agree to check all the equipment issued to me before I use it and will not use the equipment if any parts are damaged or missing. I acknowledge that I am **financially responsible** for any and all equipment that I have rented. I acknowledge and understand that while every effort has been made to ensure effective safety equipment, I will not hold SAASMaine, its owners, employees, volunteers, or staff accountable for possible safety equipment failure.
